Abstrak

This verse not only emphasizes the importance of piety, but also implies recognition of the diversity of ethnicities, nations, and races as a mandate to respect each other.

In the literature review, many researchers have examined the relationship between the Qur'an and pluralism. For example, Esposito (2002) states that the message of the Qur'an is universal and inclusive, while Nasr (2006) emphasizes that the concept of social justice and respect for differences are integral elements of Islamic teachings. 1. QS. Al-Hujurat (49:13)

QS. Al-Hujurat (49:13) reads:

"O mankind, verily We created you from a male and a female and made you into nations and tribes so that you may know one another. Indeed, the most noble among you in the sight of Allah is the most pious."

This verse is often used as the main reference in the discourse of pluralism because it states that diversity between humans is part of God's creation. The choice of the word "nations and tribes" indicates that differences in background, culture, and identity should not be a source of conflict, but rather an opportunity to recognize and learn from each other. In Gadamer's hermeneutic perspective, this verse can be interpreted as a call to build dialogue between different groups, where mutual understanding and respect for differences are the basis for the creation of social harmony.

A number of contemporary interpreters emphasize that the universal message in the verse aims to counter the tendency of exclusivism that is developing in the modern world (Nasr, 2006). In addition to QS. Al-Hujurat (49:13), there are several other verses that affirm the importance of justice and respect for differences between people. For example, QS. Al-Mumtahanah (60:8) states that Allah does not forbid Muslims to be fair and to do good to those who do not fight them because of religion. The concept of "copy knowing" conveyed in QS. Al-Hujurat (49:13) emphasizes the importance of interpersonal relationships built on the basis of justice and mutual respect.

For example, in the context of education, a curriculum that is integrated with diversity values can help the younger generation recognize and appreciate differences, thus making them agents of change who are able to reduce horizontal conflicts. The use of Gadamer's hermeneutic approach as a modern method of interpretation has received support from various academic circles. This can be seen from the increasing number of contemporary interpretations that adopt contextual and dialogical perspectives in describing the verses of the Qur'an.
