- d. 6) Pressure Social And Political

Sometimes, implementation law Islam made into issue political which hinders genuine law enforcement efforts. On the other hand, there is fear among minority communities that implementation law Islam can leading on discrimination. 7) Lack of Institutional Which Support Implementation Law Islam

Efforts to develop institutions such as the National Zakat Agency (BAZNAS) for zakat management or the Sharia Court in Aceh are positive steps, but need to be strengthened with support from the center so that the implementation of Islamic legal principles runs according to the provisions.
